
# WAYNE COUNTY PUBLIC LIBRARY OPERATING LEVY INFORMATION



#### **OPERATING FUNDS SUPPORT:**

- The purchase of new books, audio books, movies, music, magazines, games, databases, genealogy resources and tons of eMaterials (books, audio books, movies), WiFi hotspots, computers to check out, and so much more!
- Bookmobile service throughout Wayne County
- Home delivery of library materials for those who cannot travel to the library
- Free WiFi and computers at all library locations
- Story times for children and many other programs for teens, adults, and families

## Where does the Library get its funding?



This levy supports the entire **Wayne County Public Library System** which includes: libraries in **Creston**, **Dalton**, **Doylestown**, **Rittman**, **Shreve**, **West Salem**, **Wooster** and **2 Bookmobiles** with over **70** stops throughout Wayne County.

# LIBRARY OPERATING LEVY INFORMATION



#### The current Operating Levy expires in December 2022.

This levy is a renewal of a 1.1 mill operating levy plus an additional 0.2 mill. The library has been operating with funds from voter approved levies since 1993.

#### What will it cost?

The levy will cost the owner of a \$100,000 home:



One hard covered nonfiction book = \$34.10

A MONTH:



One small cheeseburger = \$2.84

A WEEK:



One half of a candy bar = 66 cents

#### Why Renewal + Additional instead of a Replacement?

	Estimated Annual cost to owner of a \$100,000 home	Revenue Generated Annually	What does this mean for the Library and for the taxpayer?
Renewal + .2 mill	\$34.10 (+ \$7.00/year)	\$3,309,700	A Renewal preserves various tax credits for the Taxpayer and the Library. The additional millage offsets the decrease in the effective rate.
Replacement	\$38.50 (+ \$11.40/year)	\$3,224,600	A Replacement returns the millage to the original effective rate; however, both the Library and the taxpayer lose certain tax credits and reimbursements. The result is that the taxpayer pays more, and the library receives less.

In summary, a RENEWAL with an ADDITIONAL 0.2 mills will generate more funds than a REPLACEMENT but it will cost taxpayers less than a REPLACEMENT. With rising costs of utilities, supplies, and staffing, a Renewal with an additional 0.2 mills is needed for the continued success of the Library and for maintaining its current service level.

#### How can you find out what this levy will cost you?

The Wayne County Auditor's website (waynecountyauditor.org) has a tool that will estimate your taxes for all levy issues appearing on your ballot.
